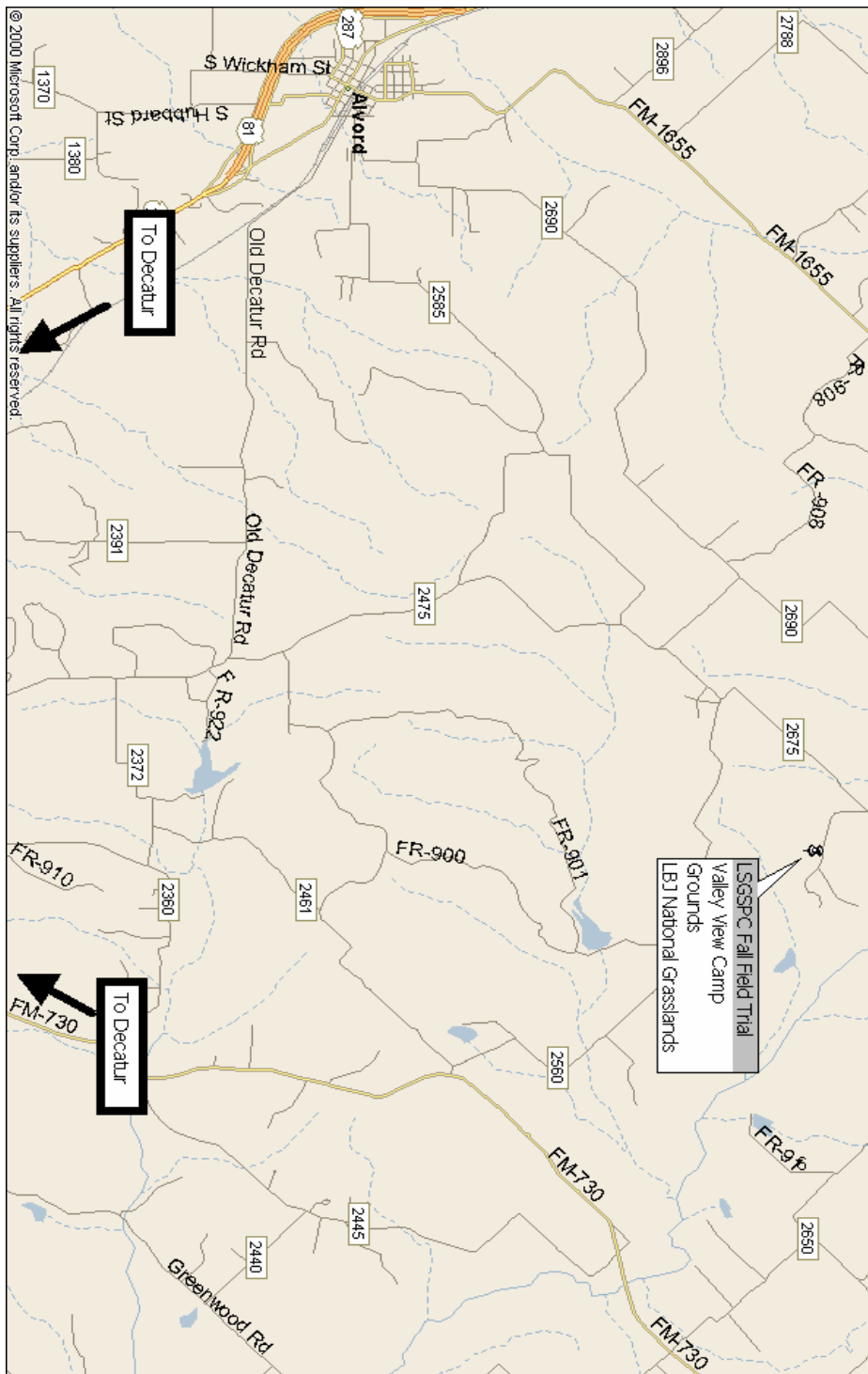
Camping is allowed on the ground, however, no campfires, please. There are no facilities at the grounds other than an outdoor rest room.
